- xxxvii. To give grants, subsidies or other assistance by medical camps for medical treatments and arrange such financing of such programmes or such other help as would be necessary in the circumstances of each case.

The Trust shall be entitled to and has power to carry out its objects and functions throughout India.

6. FUNDS AND PROPERTIES

The funds and properties of the Trust shall comprise, inter-alias of the following:-

- i. The sum of Rs.10000/- (Rupees Ten Thousands only) handed over by the Authors of the Trust to the establishment of the Trust.
- ii. All accumulations thereof and accretions thereto and all other moneys, assets or properties donated or contributed to the Trust from time to time by the Author of the Trust or by the Central or State Government or any Local or other Authority or by any other persons, Charitable Institutions, Companies, Corporations, Institutions or Organizations etc.. For the general purposes of the Trust.
- iii. Properties, both movable and immovable which may be acquired by the TRUST, by purchase, gift or in any other manner or means, whatsoever and
- iv. All income received by the Trust from properties held by it in Trust for the aforesaid purposes.

7. MANAGEMENT OF THE TRUST:

The management of the Trust is vested with **BOARD OF TRUSTEES**. They shall manage the affairs of the trust to the utmost advantage, purely on fiduciary character.

8. BOARD OF TRUSTEES:

- i. The Number of Trustees shall be Nine.
- ii. All decisions of the Trustees shall be affirmed by the majority.
- iii. The minutes of proceeding of the meeting of the Trustees or any committees shall be entered in books to be kept for the purpose and shall be signed by the Trustees. Any Trustee shall be allowed to peruse the minute book and any other books or accounts or records of the Trust at the office of the Trust.
- iv. The Board of Trustees may meet together for the dispatch or business, adjourn or otherwise regulate their meetings and proceedings as they may think fit.
- v. A resolution in writing circulated amongst all the Trustees and approved by a majority of them shall be as valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.
- vi. One of the trustees shall be elected to the post of the Managing Trust who has been given the power to preside the meeting convene the meeting and all other matters contained with the implementation of the decision taken by the Board of Trustees unless so otherwise authorized.

9. APPOINTMENT OF FUTURE TRUSTEES:

First Trustees shall be the Trustees for life. After the life-time of First Trustee or resignation of the any of the first trust trustee, the trustee shall be appointed by the Resolution of the Board of Trustee for such period as determined by the Board of Trustees.

10. POWERS OF TRUSTEES TO MANAGE SCHOOLS, COLLEGES & EDUCATIONAL INSTITUTIONS OF THE TRUST:

- i. The Board of Trustees shall have absolute power and control over the Management of all schools and colleges and other educational institutions, in management of the Trust and the Board of Trustee may if necessary appoint Committee/Committee of their choices to run the school(s) and colleges.
- ii. The bank account shall be normally operated by the any one member jointly with anyother person as authorized by the Board of Trustees by a resolution in this regard or through such other authorized representative.

- v. To make donations or contribution to any other Trusts, Institutions, Organizations etc., concerned with the well being of all people, which is recognized as an Educational Institution or Educational Trust.
- vi. To borrow money for the purpose of the Trust and on such terms as to interest, security and other matters as the Board of Trustees shall think fit.
- vii. The Board of Trustees is duty bound to fulfill the purpose of the Trust and the directions of the Author of the Trust true to its letter and spirit.
- viii. The Board of Trustees is duty-bound to preserve the Trust property and for this purpose is empowered to take such actions as is prudent and necessary for furthering the objects of the Trust.

- xi. The Board of Trustees shall have full powers to institute /or defend legal proceedings in any Civil or Criminal Courts, Tribunals or Judicial or Quasi-Judicial Authorities and in furtherance of this shall have the full powers to appoint and retain vakils, Attorneys, Solicitors or Advocates of his/her choice and shall be empowered to sign Vakalaths, pleadings, Affidavits, petitions etc.
- xii. The Trustees/Members will not be entitled to receive any remuneration as Trustee, but may reimburse himself/herself from out of the funds of the Trust, in respect of all expenses actually incurred by him in connection with the Trust or their duties relating thereto.
- xiii. The Members of the Board of Trustees and other Trustees or officers or other persons connected with the functioning of the Trust shall be indemnified for any loss incurred by him/her by virtue of holding the office of Trusteeship.
- xiv. Members of the Board of Trustees and other Trustees shall not be personally liable for anything done by him /her in good faith in the execution of the aims and objects of the Trust.

- xv. Members of the Board of Trustees and other Trustees shall not delegate any of the powers vested in him/ her under this instrument of Trust except where such delegation is necessary or is in the regular course of business.
- xvi. The Board of Trustees shall be empowered to settle out of Court, compromise or compound all suits, actions and other proceedings and all differences and demands and to refer to all or any of such differences or demands to arbitration and to execute releases and to settle all accounts without being answerable for any loss occasioned thereby.
- xvii. The Board of Trustees is empowered to enter into such contracts as are necessary for fulfilling the objects of the Trust and contracts so entered into shall be binding upon the Trust.

THE BOARD OF TRUSTEES IS EMPOWERED TO DO THE FOLLOWING ACTS AND DEEDS:

- A. To keep the Trust Properties or apply the Trust funds for the acquisition of any kind of property whatsoever including movable, immovable, actionable claims, securities, shares, stocks, bullions, jewellery or any other form of property.
- B. To invest funds of the Trust in any movable or immovable properties and further will have the power to sell or vary such investments according to their discretion from time to time. However, the pattern of investment will not deviate from the provisions of sec.13(i) (d) read with sec.11(5) of the Income Tax Act, 1961 as applicable from time to time to public charitable institutions.
- C. To sell, mortgage, lease or create any charges on the whole or any part of the property for attaining the objects of the Trust in their absolute discretion.
- D. To execute such power of attorney or attorneys to any person or persons for the purpose of executing and administering the whole or any part of the Trust and by delegation of his power to such attorney or attorneys shall only be for the purpose of conventionally, efficiently and advantageously administering the properties of the Trust and for the attainment of the objects of the Trust.

12. ADMINISTRATION

The Trustees shall have full power and authority to administer the Trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfill the performances for which the Trust is established. The Board of Trustees shall act through the Managing Trustee.

13. VOTING:

15. FUNDS AND ACCOUNTS

- i. All the income and funds of the Trust shall be used solely for the achievement of furtherance of its aims and objects and no part thereof shall be utilized for payment of any amounts to the Trustees for personal purposes.
- ii. Proper accounts of the Trust and its assets, income and expenditure shall be maintained by the Trust. Such accounts shall be closed on 31st March each year and got audited by Chartered Accountants. The balance sheet and connected statements shall be approved and countersigned by the President, Secretary and Treasures and such other members specifically authorized in this behalf each year.

16. APPLICATION OF INCOME AND TRUST FUND:

The Trustees may invests the Trust fund either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments but such transfer shall not be made which directly or indirectly for the benefit of any person referred to in sub-section(3) of section 13 of the Income Tax Act, 1961, or any subsequent amendments as may be made from time to time.

Investments of funds of the Trust shall be made in accordance with provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act, 1961.

Any of the terms of this Trust Deed may be varied, extended, amended or deleted by the Trustees from time to time with the prior approval of and subject to such conditions as may be imposed by the Commissioner of Income Tax and such variation, extension, amendment or deletion would not extend to altering the basic character/Object of the Trust and would not prove to be repugnant to the provisions of section 2(15), 11, 12, 13 and 80G of the Income Tax Act.

18. IRREVOCABILITY:

- i. The Trust is irrevocable.
- ii. In the event of dissolution or the winding up of the Trust which is beyond the scope and power of acts of the Trustees, the assets remaining as on date of the dissolution should under no circumstances be distributed to Trustees or the persons referred to in sub section 3 of section 13 of the Income Tax Act 1961 but the same shall be transferred to another Trust, Society, Association or Institution named by the Trustees whose objects are similar to those of this Trust and which enjoys recognition under section 80G of the Income Tax Act.

19. ACCOUNTING YEAR:

The financial year of the Trust shall be from 1st April to 31st March of the following year. The first financial year shall commence from the date of this deed.

20. The activities of the Trust would be purely charitable in nature, not motivated for profit. The funds of the Trust shall be applied for the aforesaid objects only within the territories of India.

21. ACCEPTANCE BY TRUSTEE:

The trustees have accepted to act as Trustees of the Trust subject to all terms, rights, duties and obligations set-out in this deed.


